Subject: Consolidated Scrutinizers Report on remote E Voting conducted pursuant to the provision of Section 108 of the Companies Act, 2013 and Rule 20(xi) of the Companies (Management and Administration) Rules, 2014, and voting at the 17th Annual General Meeting of the United Breweries Limited held on Wednesday, 7th September, 2016 at 11.00 a.m.

I, Mangala Rohith, Partner, HBP & Co, Company Secretaries, Bangalore, being appointed as Scrutinizer by the Board of Directors of United Breweries Limited, pursuant to Section 108 of the Companies Act, 2013 and Rule 20(xi) of the Companies (Management and Administration) Rules, 2014 to conduct the remote e-voting process in respect of the below mentioned resolution proposed at the Seventeenth Annual General Meeting of the members of United Breweries Limited held on Wednesday, 07th September, 2016 at 11.00 a.m.

The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting remote e-voting by the shareholders of the company.

The Notice dated 18th July, 2016 along with statement setting out material facts under Section 102 of the Act were sent to the shareholders in respect of the below mentioned resolutions proposed at the Seventeenth Annual General Meeting of the members of the Company.

The shareholders of the Company holding shares as on the cutoff date of 31st August, 2016 were entitled to vote on the resolutions as contained in the notice of the Annual General Meeting.
